**Welcome!** We are pleased that you want to consign your items at the Freedom Village Store (FVS). Those who bring their consignments to FVS can be sure the process will be handled with care and accuracy. Our consignment procedures support the FVS operating structure as a **volunteer-run** enterprise and follow generally-accepted practices in the resale industry. We ask that you please follow these procedures so we may provide you with the best possible environment in which to sell your items.

FVS accepts items for consignment by appointment only. To make an appointment, contact our management consultant, Miranda Sandahl, at <a href="mailto:freedomvillagestore@gmail.com">freedomvillagestore@gmail.com</a>, or call 603-539-3077, to set a mutually agreeable time to bring in and review the items you wish to consign. Larger items may be previewed by photo (either via email to the above address or on a camera or cell phone during your in-store appointment).

All consignment items must be clean, free of dust or stains, polished, and be in desirable condition and quality for resale. Please take the time to make your items look their best because their appearance will determine how quickly they sell and at what price. Also, please let us know if there is special information about an item that you wish to include that will help it sell -- for example, age of an antique, type of wood, well-known manufacturer, or special edition item.

FVS will accept items that we believe our customers will buy. Sometimes there will be items we cannot sell. Please understand that our customers' preferences are key to our selection guidelines. In addition, we may need to limit certain items depending upon space constraints and/or volume of like items already in the Store.

3.	FVS will complete an inventory of consigned goods to include price and consignment ending date which the Consignor will sign for acceptance. A copy will be provided to the Consignor and another for FVS file.	
4.	FVS reserves the right to accept or reject any items and reserves the right to limit the total quantity of items per Consignor. FVS will work with Consignor to determine acceptable selling price.	
5.	Consignment items must be clean, free of dust or stains, polished, and in desirable condition and quality for resale.	
6.	FVS will provide space to display consigned items in exchange for 30% of the selling price.	
7.	FVS agrees to pay the Consignor 70% of the selling price. FVS will provide the Consignor with an accounting of items sold, the selling price, and remittance of monies collected within 15 days after the end of each month FVS will not issue a check on sales of less than \$10 in any month.

8.	FVS reserves the right to reduce the price of consigned items in 10% increments after 90 days of the 5-mont consignment period. Total reduction will not exceed 30% of the original price without approval of the Consignor.	
9.	Consignors may pick up unsold items by appointment at the end of the 5-month consignment period. Any items removed must be signed out of the FVS consignment inventory.
